# terms and conditions

Company registration : 211-10-76943 (SMK)

## 1/ GENERAL RULES

- a) Each order entails automatic acceptance of these terms & conditions
- b) The use by the client of the collaboration line's place of sale should be accepted first by S M K's written notice.
- c) The client shall not remove or cover brand names on delivery products. S M K trademark shall only be used in such a way or form previously accepted by S M K.

## 2/ ORDERS

- d) The brand S M K has the right to accept or refuse any orders made by the client.
- e) Cancellation of orders made 60 days before delivery of the products should be compensated by the payment of 50% from the client of his total order.
- f) All samples provided should be regarded as type of samples and all information in sales catalogue as approximate. The client must accept the discrepancies between type samples and delivered goods insofar the delivery is not significantly different from the typical sample

## 3/ PAYMENT CONDITIONS

- a) The prices of the brand S M K are made in USD pre-tax, to convert any of orders in other currencies, client should refer to S M K first before switching currencies.
- b) The client shall pay 50% deposit when contracting the order and the 50% balance in a period of 7 days after reception of the goods.
- c) The 50% deposit should be paid by client in a period of 10 days after issue the invoice. After a period of 20 days, the order will be considered as cancelled.
- d) Any delay in the payment of the 50% balance will be charged by a penalty of 10% of total order first week and 20% of total order on second week. After the third week, the penalty will be 30% of the total order.
- e) All payment should be transferred through international bank wire (all bank fees on the client side) or through paypal (the clients shall bear the 4.4% paypal fee)

## 4/ DELIVERIES

- a) The merchandise is always transported to the expenses of the client, who can choose his own freight, company and insurance. If the client doesn't have any preferences, the merchandise will send to him by EMS EXPRESS (Delivery in five to seven days) at his own expense and depending of the availability of this service in the country the customer resides\*
- b) The return of the merchandise is exceptional and may be accepted by S M K within 24 hours of the clients receipt of the merchandise.
- c) S M K reserves the right to postpone the delivery date indicated on the confirmation of order for up to 30 days.
- d) Any inability to deliver arising from a majeure situation ( fire, war, strike, labour conflict, flood, accident...) shall release S M K from having to fill orders, in which case no compensation may be demanded.

- e) If any good is received with a defect, the client shall communicate with S M K in a period of 24 hours. If the defect is approved by S M K, the item will be exchanged or refunded within 15 days.

## 5/ LAW

- a) Any dispute and the present terms and condition are subject to the Korean law with the exception of any internationally recognized private regulations applicable at any given time.

## 6/ COMMUNICATION

- a) The client should always communicate the collaboration on his webiste, social networks & others by always mentioning & taggings the brand S M K. If the client doesn't do so, the brand will be entitled to use the picture of the clients for its own.
